<u>Note:</u> Note: The Head of a Marriage Registration Office is obliged to explain the conditions mentioned in the present Marriage Contract Booklet to the marrying couple and have the mutually-agreed conditions undersigned by the marrying couple.

Conditions of the Marriage Contract or a Separate Binding Contract:

A- By this present marriage contract/ through a separate binding contract, the wife stipulated that if the divorce does not come at her request and the lawsuit for divorce is not due to a violation of her marital duties or her ill humor or bad character according to a court discernment, the husband shall be obliged to transfer to the wife a portion of up to half of the assets or their equivalent that he has earned during the marital life share together with her.

B- By this present marriage contract/ through a separate binding contract, the husband grants his wife an irrevocable power of attorney, including the right to delegate authority to a third party, to file a legal case at a court of law in the following cases, and upon receipt of the necessary ruling, she shall have the power to select the type of divorce and finalize the divorce formalities on his behalf. She shall also be authorized to accept a bestowal [on his behalf] in case it is presented:

In the following instances, the wife can refer to the court and apply for divorce as the case may be:

- 1-When the husband refuses to pay alimony and it is not possible to compel him to do so, or when he refuses to fulfill other essential marital obligations owed to his wife and those obligations cannot be enforced.
- 2- Misconduct or participation in harmful relations by the husband, such that continuing the marital relationship becomes unbearable for the wife.
- 3- Severe and intractable illness in the husband that can endanger the life of the wife if the marriage continues.
- 4- Insanity of the husband where the dissolution of the marriage is not reasonably possible.
- 5- Disobedience of a court order prohibiting the husband from engaging in an occupation deemed inconsistent with family interests or disrespectful of the dignity of the wife.
- 6- When the husband has been convicted and sentenced to five or more years in prison, including instances where the convict is incarcerated due to inability to pay imposed fines, and he is serving the term of imprisonment.
- 7- When the husband is afflicted with a harmful addiction as determined by a court's judgment, and such addiction is capable of damaging the foundation of the family or rendering the continuation of married life unfeasible for the wife.
- 8- Abandonment of family life by the husband. Whether such abandonment has occurred, or if it stands to be excused, shall be determined by the court's considered judgment. Additionally, if the husband is absent for six consecutive months without reasonable excuse which is decerned by a court of law
- 9- Definitive conviction of the husband resulting from the commission of a crime for which he receives punishment, whether it be a Hadd [punishment prescribed by Shariah law] or Ta'zir [discretionary punishment determined by the court], due to an offense deemed inconsistent with preserving the dignity, esteem and honorable reputation of the wife within her family and community standing. The court reserves sole judgment in evaluating what constitutes damage to the wife's prestige and honor through consideration of her family status and background, local customs, and other applicable criteria.
- 10- When the husband is infertile or otherwise physically incapable of bearing a child jointly with the wife.
- 11- In the event of the husband's intractable absence such that he cannot be located for six months following an application made by the wife to the Court seeking his whereabouts.
- 12- When the husband enters into another marital union without obtaining proper consent from his present wife, or if his conduct towards and among his wives is deemed unjust or inequitable as verified by the Court.
