Dear owner, please attentively study and observe the following remarks:

١) All drivers are obliged to strictly observe traffic regulations in order to respect the rights of others and reduce damages resulting from infringement of such regulations.

Hereinafter all infringements and driving records will be registered in the name of the owner of the number plate; therefore, the vehicle owner will be responsible for allowing others to drive his/her vehicle.

٢) It is mandatory to care for and protect the number plate; therefore:

A) Always keep the number plate clean and legible, and take care that it has been fitted properly in place.

B) The vehicle owner is required to forthwith report lost or damaged vehicle license or number plate to a nearest Police Station, and personally apply to the transference or traffic departments within ٤٨ hours for obtaining a duplicate vehicle license or number plates.

٣) Upon selling or transferring the vehicle, both parties have to apply to the transference centers, taking the transacted vehicle and holding personal identity documents, including, original national ID card, birth certificate, compulsory military service completion card or permanent exemption card, as well as the identity documents of the vehicle, including vehicle title deed and license, MOT test pass certificate, government debts and duties payment certificates.

Notes:

A) In order to expedite and facilitate the transference, you are strictly recommended to plan such transference to be conducted in the city of the new owner's abode.

B) Regarding that the number plate has been registered in your name, in case of sale or transference of the vehicle, your number plates have to be removed from the vehicle at the transference centers under the police supervision and allocated to the new owner and fitted on the vehicle in presence of the police.

٤) Regarding that the vehicle license and any other service are provided only to the address of the owner's permanent abode, based on the article ٦ of traffic regulations, in case of changing his/her address of permanent abode, the owner is obliged to write his/her new address on address change form provided to him/her together with the vehicle license up to ١٠ days and send the same to the authority set out in the form within ٤٨ hours.
